Cardiovascular disease (CVD) remains the leading cause of death for women in the United States, and morbidity and mortality rates continue to rise despite medical advances and campaigns to increase awareness. There is a lack of awareness of sex-specific risk factors and differences in clinical presentation, which often leads to delays in care. And when medical attention is sought, women are often misdiagnosed and/or undertreated.


